Information Packet for Prospective Employees

Upon completion of the following, all documents must be submitted to Karen Moyer, Human Resources Coordinator, prior to commencement of your employment.

Step I

Act 168 of 2014 amended the Public School Code of 1949, to provide direction regarding employment history reviews of all prospective employees.

Prior to working for BCTHS, you must complete the Commonwealth of Pennsylvania Sexual Misconduct/Abuse Disclosure Release Form for each employer with whom you had direct contact with children. The completed form(s) must be completed and returned to Karen Moyer, Human Resources Coordinator, immediately.

Step II

Act 153 of 2014 requires all prospective employees of public and private schools, intermediate units and area vocational-technical schools, to provide to the employer three background checks: the Federal Criminal History Record; the Pennsylvania State Criminal History Background Check; the Child Abuse History Clearance. These clearances must be renewed every five years.

Obtain your Federal Criminal History Record, as follows:

Fee: \$23.85

- You must register on the Identogo website or by making a phone call prior to going to the fingerprint location.
- Register online at <https://uenroll.identogo.com>.
- Enter the following Service Code: 1KG6NX
OR
- Schedule an appointment online or by calling 844.321.2101.
- You will need to bring ID with you to the fingerprint location. Review the attached list of acceptable pieces of identification.
- After you register, print the final page of your registration. You will also receive an email confirmation. Both will have a "UE ID" Code.
- Take the sheet with the "UE ID" Code, your piece of ID, and method of payment with you to the fingerprint location.
- Payment will be made at the fingerprint location with a credit card or money order only.
- Submit the receipt you receive from Identogo.
- Your results will be sent to your email address. You will have one opportunity to open the email and print the results.
- Submit your results and/or your "UE ID" Code.

- You will need to create an account in order to submit your request.
- You may request that a copy be mailed to your home.
- You will receive an email when your results are complete.

Step III

You must take the School Health Personnel Record to your physician. Your physician will complete the physical examination and the required TB Test.

Step IV

You must provide documentation in order to complete the Form I-9.

Please review the sheet entitled, List of Acceptable Documents and bring these to school when you drop off the paperwork. You may bring only one original item from Column A ***or*** one original item from Column B ***and*** one original item from Column C. ***Copies are not acceptable – you must produce originals.***

(Pursuant to Act 168 of 2014)

Instructions

This standardized form has been developed by the Pennsylvania Department of Education, pursuant to Act 168 of 2014, to be used by school entities and independent contractors of school entities and by applicants who would be employed by or in a school entity in a position involving direct contact with children to satisfy the Act's requirement of providing information related to abuse or sexual misconduct. As required by Act 168, in addition to fulfilling the requirements under section 111 of the School Code and the Child Protective Services Law ("CPSL"), an applicant who would be employed by or in a school entity in a position having direct contact with children, must provide the information requested in SECTION 1 of this form and complete a written authorization that consents to and authorizes the disclosure by the applicant's current and former employers of the information requested in SECTION 2 of this form. The applicant shall complete one form for the applicant's current employer(s) and one for each of the applicant's former employers that were school entities or where the applicant was employed in a position having direct contact with children (therefore, the applicant may have to complete more than one form). Upon completion by the applicant, the hiring school entity or independent contractor shall submit the form to the applicant's current and former employers to complete SECTION 2. **A school entity or independent contractor may not hire an applicant who does not provide the required information for a position involving direct contact with children.**

Relevant Definitions:

Direct Contact with Children is defined as: "the possibility of care, supervision, guidance or control of children or routine interaction with children."

Sexual Misconduct is defined as: "any act, including, but not limited to, any verbal, nonverbal, written or electronic communication or physical activity, directed toward or with a child or a student regardless of the age of the child or student that is designated to establish a romantic or sexual relationship with the child or student. Such acts include, but are not limited to: (1) sexual or romantic invitation; (2) dating or soliciting dates; (3) engaging in sexualized or romantic dialogue; (4) making sexually suggestive comments; (5) self-disclosure or physical exposure of a sexual, romantic or erotic nature; or (6) any sexual, indecent, romantic or erotic contact with the child or student."

Abuse is defined as "conduct that falls under the purview and reporting requirements of the CPSL, 23 Pa.C.S. Ch. 63, is directed toward or against a child or a student, regardless of the age of the child or student."

Please Note

A prospective employer that receives any requested information regarding an applicant may use the information for the purpose of evaluating the applicant's fitness to be hired or for continued employment and shall report the information as appropriate to the Department of Education, a state licensing agency, law enforcement agency, child protective services agency, another school entity or to a prospective employer.

If the prospective employer decides to further consider an applicant after receiving an affirmative response to any of the questions listed in SECTIONS 1 and 2 of this form, the prospective employer shall request that former employers responding affirmatively to the questions provide additional information about the matters disclosed and include any related records. The **Commonwealth of Pennsylvania Sexual Misconduct/Abuse Disclosure Information Request** can be used to request this follow-up information. Former employers shall provide the additional information and records within 60 calendar days of the prospective employer's request.

The completed form and any information or records received shall not be considered public records for the purposes of the Act of February 14, 2008 (P.L. 6, No. 3) known as the "Right to Know Law."

The Department of Education shall have jurisdiction to determine willful violations of Act 168 and may, following a hearing, assess a civil penalty not to exceed \$10,000. School entities shall be barred from entering into a contract with an independent contractor who is found to have willfully violated the provisions of Act 168.

Pursuant to Act 168, an employer, school entity, administrator, and/or independent contractor that provides information or records about a current or former employee or applicant shall be immune from criminal liability under the CPSL, the Educator Discipline Act, and from civil liability for the disclosure of the information, unless the information or records provided were knowingly false. Such immunity shall be in addition to and not in limitation of any other immunity provided by law or any absolute or conditional privileges applicable to such disclosure by the virtue of the circumstances of the applicant's consent thereto.
